## STALLION BREEDING CONTRACT

### *Camelot's Lonestar*

### 1993 Chestnut Arabian Stallion

### Stallion Breeding Fees

Breeding Fee:	\$1200.00
Booking Fee:	\$ 200.00 Non-refundable (Applied to the Breeding Fee)
Mare Care:	\$ 5.00 Per Day Dry and \$6.50 Per Day Wet

### Transported Semen Fees

Breeding Fee:	\$1200.00
Booking Fee:	\$ 200.00 (Applied to the Breeding Fee)
Collection/Processing Fee:	\$ 225.00 Per Shipment (excluding first shipment)
Equitainer Deposit:	\$ 150.00 Per Shipment**
Airport Fee (if applicable)	\$ 50.00 Per Shipment

\*\*Equitainer must be returned to Breeder within 5 days after receipt, at which time the full deposit will be refunded. A \$25.00 per day charge will be assessed for each day over 5 that the Equitainer is not returned and will be deducted from the Deposit.

### Breeding Terms/Conditions/Procedures

1. This is a "Live Foal Guarantee" out of the above Mare and Stallion. Live foal means the foal shall stand and nurse and subsequently live for 24 hours after birth. It is understood that if the mare proves barren, aborts her foal, or if the foal is stillborn, a return season will be guaranteed for the 2004-breeding season, providing proper notification is give. Proper notification shall be defined as follows: written certification by a licensed veterinarian within seven days from date of loss of said unborn foal or foal that does not survive the first 24 hours.
2. A breeder's certificate will be issued for the foal, conceived by this mating, provided the stallion fess and all other expenses are paid in full.
3. Mare owner hereby agrees that Stallion owner reserves the right to refuse service to any mare which appears to be diseased or which is unfit for breeding, in the opinion of the Stallion owner.

4. Arc Angel Arabians will exercise every effort to settle the Mare. A uterine culture and biopsy will be required at the owner's expense if the mare does not settle after 3 cycles.
5. Should the stallion be sold, die, become unfit for breeding, or semen collection, or if the above named Mare dies, during the breeding season then the mare owner may substitute another mare or breed the above named mare to another stallion on the farm that is agreed to by both the Mare and the Stallion owner.
6. The Mare Owner is responsible for providing a photocopy of both sides of registration papers on above named mare no matter the breed registry.
7. Booking Fees are due and payable at the time this Contract is signed and must be submitted with Contract.
8. This contract is non-assignable and non-transferable.

#### **Live Cover Conditions:**

1. Breeding Fee and Mare Care expenses are due and payable prior to Mare's departure from Arc Angel Arabians.
2. Mare Care Fees are non-refundable.
3. The Mare Owner shall be responsible for providing the Breeder with a copy of a negative Coggins test (presented upon arrival). Mare owner certifies that the Mare is in good health and up to date on all vaccinations prior to arrival at Arc Angel Arabians.
4. Both parties agree that the Breeder/Farm and any person associated with Breeder/Farm is not liable for death, sickness, including consequential damage caused by the mare and/or foal; and that the Mare Owner is not liable for death, sickness, including consequential damages to the stallion. It shall be the Mare Owner's responsibility to maintain mortality insurance for their mare and foal if desired.
5. If Stallion Owner deems live cover to be perilous to stallion, mare, and/or handler artificial insemination will be offered as an alternative.

#### **Artificial Insemination Conditions:**

1. Semen must be requested at least 24 hours prior to shipping date. Cancellation of shipments made by 8:00a.m. the scheduled day of shipment may be made with no penalty. Cancellation made after 8:00a.m. on the scheduled day of shipment will incur a penalty of \$\_\_\_\_\_.
2. Semen is collected at your request. Obviously collection on Saturdays and Sundays offer different circumstances. All requests for semen will be filled as received, subject to availability and there is a slight possibility that excessive demand for a certain day will necessitate that we have to reschedule your shipment.
3. Stallion Owner agrees to ship Mare Owner semen that will be viable for a minimum of 36 hours after leaving the Stallion Owner's possession. In the event that a semen shipment does not meet insemination criteria, a licensed veterinarian must issue a written certificate documenting that the semen shipment was not suitable for use, that proper and accepted handling procedures were taken during the inspection process and the date and time of inspection. When the stallion Owner receives proper documentation (via fax is acceptable) a replacement shipment may be shipped to the mare owner at no additional cost.
4. Arc Angel Arabians is not responsible for lost, delayed, or damaged semen after it leaves the farm except for the above mentioned replacement shipment. We make no representations or warranties of any kind with respect handling and care methods for U.S. Mail, Fed-Ex, UPS or any other shipping companies.
5. Breeding Farm will pay the shipping charges for regular Federal Express (Fed-Ex) overnight or UPS next day delivery. Please be aware that there is no pick-up or deliver on SUNDAY.

(There is pick-up on Friday for Saturday delivery in most areas, but no pick-up on Sunday for Monday delivery.) Under some circumstances, alternative-shipping arrangement can be made at the owner's expense. There will be an additional \$200.00 fee for same day service.

6. It is essential that you call Arc Angel Arabians on the first day of your Mare's heat cycle to schedule the semen shipment.
7. A request for shipment of cooled transported semen must be made by 5:00p.m. at least 24 hours prior to shipping time to insure your name is on the shipment list for the next day.
8. Have you veterinarian contact us at least twice:
  - a. When he/she first makes a "best guess" predicting ovulation of the Mare;
  - b. When he/she wants the semen to be shipped or insemination 24 hours later.
9. When you receive the Equitainer, DO NOT OPEN it until the veterinarian is present and ready to inseminate your Mare. Store in a safe area.
10. In the event that Mare Owner contracts separately with "Shipped Semen Station" for receiving semen on behalf of the mare owner and/or reproductive services, Arc Angel Arabians must be notified in writing of the arrangement, be supplies with the name and phone number of a contact person and must have on file a signed statement from mare owner allowing shipped semen facility to act as their agent. Mare Owner agrees to hold Arc Angel Arabians, their employees or agents blameless for any actions taken by Shipped Semen Facility. Further, Mare Owner agrees that any costs associated with shipment of semen, as outlines above, are a separate agreement between Arc Angel Arabians and Mare Owner.
11. Transported Semen: Breeding Fee, Collection/Processing Fee, Equitainer Deposit and Airport Fee (if applicable) are due and payable 10 days prior to shipment of semen.

This contract is entered into in the state of Michigan and will be interpreted and enforced under the laws of the state of Michigan.

This contract represents the entire agreement between both parties. When mare owner and breeder sign this contract, it will be binding for both parties with the above terms and conditions.
